Dear prospective Stall Holder,

What a rollercoaster of a year it has been already! However, we are delighted to advise that the **Dalgety Show is going full steam ahead** and will be held on **Sunday 6th March 2022**. As usual there are a limited number of sites available for stall holders – we can't wait! We would love to have you represented there, so here is some useful information.

All standard sites are 3x3m, unpowered, uncovered sites. The cost per standard site for retailers is \$25. The cost per standard site for food/drink vendors is \$50. Please let us know if you have any requests on site size, the location of your stall, if you require power or any other site specific request. We will try to accommodate all requests, however these are not guaranteed. If you do not have any specific requests you will be allocated a standard unpowered site and this cannot be changed on the day. You also need to figure out how many sites you need if you have large equipment for example.

Stall holders are asked to be at the grounds between 6.30am and 7.45am on Sunday morning for unloading. Expect some delay getting to your site and please follow the directions of the Dalgety Show Steward volunteers. All vehicles must be removed by 7.45am due to the early starting events and the presence of their spectators (dog trials and horse events), and this will be enforced for safety. We anticipate you will be able to pack-up from approximately 4pm and there will be vehicle access for your departure after you have been advised by the groundsman, again for safety reasons.

If you would prefer, you can set up on Saturday afternoon between 3pm and 7pm by arrangement – please contact me to organise this. You will have to provide your own security if required however.

It is a requirement of the Royal Agricultural Society and the local regional Council that all users of showgrounds, including stall holders, must be insured for **\$20 million public liability**. We need a record of your policy, so please supply a copy of your Certificate of Currency with your booking form. Alternatively, you are very welcome to get a one day cover for \$20 under the Dalgety Show Society by completing the attached form and returning it with your booking.

All electrical equipment or leads must be tagged with current approval and this will be strictly enforced.

To make it easier on the day, stall site fees will be paid prior to show day – once we have received your booking form we will send you an invoice, and your site will be confirmed on receipt of payment. Possible costs include:

- Site fee (for each standard 3mx3m site it is \$25 for a general or retail site and \$50 for a food or drink vendor site - there is no charge for a community/charity site)
- Insurance fee of \$20 if we do not receive a copy of your C of C with the booking. Even a photo of your policy from your phone attached with the booking form is fine, we just need to confirm it is current and for **\$20M**

On the day you will need to pay the show entry fee on arrival at the gate, but in 2022 there is  
**ONE FREE SHOW ENTRY PER STANDARD 3x3m SITE BOOKED.**

Just a reminder about times:

- Vehicle access in: Saturday by arrangement 3pm-7pm OR Sunday 6.30am-7.45am
- Vehicle access out: Sunday after 4pm/notified by groundsman
