Dear prospective Stall Holder,

We are delighted to advise that the iconic **Dalgety Show is on again** and will be held on **Sunday 3rd March 2024**. As usual there are a limited number of sites available for stall holders, so please return your completed booking form and \$20 million public liability insurance details **by Friday 2nd February** – thanks!

All standard sites are 3x3m, unpowered, uncovered sites. The cost per *standard unpowered site for is \$25*. The cost per *standard powered site is \$50*. Please let us know if you have any requests on site size, the location of your stall, if you require power or any other site-specific requests. We will try to accommodate all requests; however, these are not guaranteed. If you do not have any specific requests you will be allocated a standard unpowered site and this cannot be changed on the day. You also need to figure out how many sites you need, especially if you have large equipment.

Stall holders are asked to be at the grounds between 6.30am and 7.45am on Sunday morning for unloading. Expect some delay getting to your site and please follow the directions of the Dalgety Show Steward volunteers. All vehicles must be removed by 7.45am due to the early starting events and the presence of their spectators (dog trials and horse events), and this will be enforced for safety. We anticipate you will be able to pack-up from approximately 4pm and there will be vehicle access for your departure after you have been advised by the groundsman, again for safety reasons.

If you would prefer, you can set up on Saturday afternoon between 3pm and 7pm by arrangement – please contact me to organise this. You will have to provide your own security if required however.

All *commercial* users of showgrounds, including stall holders, must be insured for **\$20 million public liability**. We need a record of your policy, so please supply a copy of your Certificate of Currency with your booking form. All *hobbyist* stall holders (no ABN and earn less than \$20k from stall activity per year) can be covered under the Show Society's public liability insurance. The ASC's Public Liability insurance does not extend to Hobbyists in any manner for any Products Liability exposure. A \$20 administrative fee applies. The hobbyist stall holder declaration must be signed.

All electrical equipment or leads must be tagged with current approval and this will be strictly enforced.

To make it easier on the day, stall site fees will be paid prior to show day – if we have **received your booking form by Friday 2nd February**, we will send you an invoice, and your site will be confirmed on receipt of payment. Possible costs include:

- Site fee (for each standard 3mx3m site it is \$25 for a unpowered site and \$50 for a powered site - there is no charge for a community/charity site)
- Administration fee of \$20 for hobbyist stall holders. For commercial operators, even a photo of your policy from your phone attached with the booking form is fine, **PLEASE CHECK IT IS FOR \$20M!!!**

On the day you will need to pay the show entry fee on arrival at the gate, but in 2024 there is
ONE FREE SHOW ENTRY PER STANDARD 3x3m SITE BOOKED.

- Vehicle access in: Saturday by arrangement 3pm-7pm OR Sunday 6.30am-7.45am
- Vehicle access out: Sunday after 4pm/notified by groundsman
- No dogs
